\* The California Privacy Rights Act amendments to the California Consumer Privacy Act have been in effect since January 1, 2023 and are enforceable as of July 1, 2023. However, the Sacramento Superior Court has held that implementing regulations cannot be enforced until 1-year after they are finalized. See <u>California Chamber of Commerce v. California Privacy Protection Agency</u>. \*\* The constitutionality of the California Age-Appropriate Design Code Act is being contested in <u>NetChoice v. Bonta</u>.
